## Our Next Event in Copenhagen on June 16, 2014

to be held in conjunction with the **2014 IACCM Academic Forum**, organized by Copenhagen Business School and the International Association for Contract and Commercial Management (IACCM) during the **IACCM Europe Forum 2014** (see <u>http://www.iaccm.com/europe14</u>) on 16–18 June 2014. The general theme of this year's Academic Forum is **Modern Contract Management: Integrating contract theory, law, and organization studies**. In addition to the ProActive ThinkTank and the Nordic School of Proactive Law, the event is supported by Århus University and Southern Danish University.
