# **George J. Siedel**, Professor of Business Law & Business Administration University of Michigan Business School:

## Moving from Product Liability to Product Innovation

Company managers often view the law as a burden or an obstacle, rather than as a source of competitive advantage. This presentation will discuss a process called the Manager's Legal Plan that provides a tool that business managers and lawyers can use to move beyond "flight or fight" reactions to legal concerns. This tool enables them to use law proactively as a source of competitive advantage by developing business strategies and solutions to reduce costs by preventing future legal problems and reframing legal concerns as business concerns.

Professor Siedel is the author of the book *Using the Law for Competitive Advantage* (Jossey-Bass 2002). He has received several research and teaching awards and served as a Visiting Professor at Harvard University, the University of Sydney, Stanford University, and the University of Cambridge.
